ORDER

Sri.Abdul Muneer. K.A., Assistant Gr.II was granted LWA for 20 years from 06.09.1989 to 05.09.2009 to take up employment abroad.

After the expiry of LWA on 5.9.2009, Sri.Abdul Muneer. K. A. has neither reported for duty nor communicated any reason for the non-joining. His absence from 06.09.2009 has been treated as unauthorized absence which amounts to violation of the provisions in Kerala Service Rules and Kerala Government Servants Conduct Rules. There for University initiated disciplinary action against him.

He has been served with show cause notice No.GA/A2/28924/06 on 9.11.09 and 31.10.10. The notice dated 9.11.09 was served to his home address in Kerala only and the same was returned by the postal authority with endorsement addressee left back. One copy of show cause notice dated 31.10.2010 was served to his home address and another to his address at abroad. The letter addressed to home address returned by the postal authority.

As such another show cause notice as read 3rd was issued. A brief of the show cause notice has been published in two dailies dated 05.06.2011 and full version of show cause notice published in Kerala Agricultural University website. In this show cause notice, Sri. Abdul Muneer was asked to explain as to why his services should not be terminated within 15 days from the date of publication of the notice. He has not submitted any explanation till date.

In these circumstances the following orders are issued.

Sri. Abdul Muneer K.A., Assistant Gr.II, Regional Agricultural Research Station, Pilicode is removed from the service of Kerala Agricultural University which shall not be a disqualification for future employment as per Section 23(vii) of SRO 293/72.
