ORDER

Sri.Abdul Jabbar T.P., Junior Programmer, Regional Agricultural Research Station, Pilicode was granted Leave without allowances for 20 years from 22.10.1990 to 21.10.2010 to take up employment abroad. He has therefore availed maximum period of leave of this kind.

After the expiry of Leave without allowances on 21.10.2010, Sri.Abdul Jabbar T.P. has neither reported for duty nor communicated any reason for his non-joining. His absence from 22.10.2010 has been treated as unauthorized absence which amounts to violation of the provisions in Kerala Service Rules and Kerala Government Servants Conduct Rules. There for University initiated disciplinary action against him.

He has been served with show cause notice. The notice was served to his address in abroad and the same was returned by postal authority. As per letter dated 09.02.2011, the Associate Director , Regional Agricultural Research Station, Pilicode has been requested to serve the show cause notice in his residential address. Nothing has been heard from Sri.Abdul Jabbar T.P.

A brief of the show cause notice has been published in two dailies dated 20.02.2011 and full version of show cause notice published in Kerala Agricultural University website. In this show cause notice, Sri.Abdul Jabbar T.P. was asked to explain as to why his services should not be terminated within 15 days from the date of publication of the notice. He has not submitted any explanation till date.

In these circumstances the following orders are issued.

Sri.Abdul Jabbar T.P., Junior Programmer, Regional Agricultural Research Station, Pilicode is removed from the service of Kerala Agricultural University which shall not be a disqualification for future employment invoking Section 23(vii) of SRO 293/72.
