Recruitment of Assistant Professors

Applications in the prescribed format are invited from eligible candidates for appointment as Assistant Professors in various disciplines under the faculties of Veterinary & Animal Sciences, Agriculture, Fisheries and Agricultural Engineering in Kerala Agricultural University.

Period of Appointment:-

The period of appointment shall be for a period till the incumbents attain superannuation as laid down in Section 42 (4) and (5) of Kerala Agricultural University Act.

The candidates should belong to the concerned communities for which the post is reserved. The candidates belonging to other backward communities should enclose a 'Non-creamy Layer' certificate issued by the competent authority as provided in G.O.(Rt.) No.15/2000/SC/STDD dated 16-02-2000, 117/08 dated 19.12.2008 and its subsequent amendments along with the application duly filled in. Otherwise their candidature will not be considered for reservation quota. The candidates should further note that the number of vacancies notified is provisional and is liable to vary.

- (i) **The application should be in the format provided in KAU Website and should be down loaded in A4 size paper. All columns in the form should be filled in properly and legibly. If any column is irrelevant, the same should be filled up by the entry "N.A." that is "Not Applicable" and should not be left blank or filled up by dots or hyphen or any other mark.**
- (ii) **If there is a difference in the name of the candidate given in the application and that given in the documents, an identity certificate from a Gazetted Officer showing that the name given in the application and in the documents are of the same person, should be attached with the application.**
- (iii) **The envelope containing the application should be superscribed with the name of post and discipline applied for.**
- (iv) **Candidates who are already in service should send their applications through proper channel.**
- (v) **Before applying for the post, the candidate should ensure that he/she fulfils the eligibility and other norms prescribed thereto. The University reserves the right to reject any application at any stage of the recruitment process if the candidate is found ineligible for the post for which he/she applied. If appointed, such a candidate is liable to be summarily removed from the service.**

- (vi) **Q**ualifications prescribed including experience for a post shall be one acquired by the candidate on or before the last date fixed for the receipt of filled-in application i.e., the candidate must have passed all the examinations conducted for the purpose for attaining the qualifications prescribed for the post and, those who have “appeared only” will not be considered to be called for interview.
- (vii) **N**o interim enquiry regarding selection will be entertained.
- (viii) **C**anvassing in any form will disqualify the candidate.
- (ix) **L**ast date and time fixed for receipt of filled-in application to the undersigned is on or before **25.03.2010** at 5.00 p.m.
- (x) **A**pplications received late, incomplete or in defective form will be summarily rejected.
