ORDER

As per University order read as 1st paper, Smt. Darley Jose, Assistant Professor, Farming Systems Research Station, Sadanandapuram, Kottarakkara had been granted study leave for 3 years from 09.03.1996 to 28.03.1999 for undergoing Ph.D. programme at Centre for Development Studies, Thiruvananthapuram. She has neither executed the prescribed bond as per rules nor rejoined duty after expiry of leave. Hence disciplinary action was initiated against her and a memo of charges issued. Following charges were leveled against her.

- i) Failure in executing the bond as ordered by the University.
- ii) Unauthorised absence w.e.f. 29.03.1999
- iii) Insubordination and violation of Kerala Government Servants Conduct Rules.

Though she has acknowledged the receipt of memo of charges on 04.10.2002 vide acknowledgement delivered by Postal authorities no reply has been received from her within the stipulated time. University has viewed this very seriously and decided to go head with the disciplinary proceedings.

In University order read as 2nd paper a formal and detailed enquiry as pr KAU Statute SRO 293/72 was ordered. The Officer of enquiry submitted the report on 03.12.2007. It is reported that the charges leveled against Smt. Darley Jose stand proved in the enquiry. It was also reported that she is not working in Centre for Development Studies, Thiruvananthapuram presently and she seems to be residing somewhere in Norway.

The whole matter was placed before the Executive Committee and the Executive Committee in its 461st meeting held on 13.10.2009 has decided to terminate her service as per rules.

Though she has acknowledged receipt of the show cause notice read as 3rd paper, she has not furnished reply within the stipulated time.

In these circumstances, in consonance with the decision of Executive Committee of Kerala Agricultural University in its 461st meeting held on

13.10.2009, Smt. Darley Jose, Assistant Professor, Farming Systems Research Station, Sadanandapuram, Kottarakkara is dismissed from the services of Kerala Agricultural University w.e.f. 29.03.1999 as per Section 23 (vii) of SRO 293/72.
